





DOGTROPHY 2021

- ▶ **1 PLASTIC TUBE**
- ▶ **2 ON/OFF BUTTON AND LED**
- ▶ **3 EXTERNAL ANTENNA**
- ▶ **4 CHARGING PORT**
- ▶ **5 FOAM BALL (3)**
- ▶ **6 DOGTROPHY STRAP**
- ▶ **7 VERTICAL STAND ***

HOW TO CHARGE

- ▶ Plug the adapter into the charging port ④
- ▶ Plug the adapter into a wall plug
- ▶ While charging the ON/OFF LED ② will turn green and start blinking
- ▶ When fully charged: The ON/OFF LED ② light is ON
- ▶ Full charge takes \pm 4 hours, depending on which adapter is used
- ▶ The battery can last up to 5 days in STANDBY MODE (**DOGTROPHY ON**)

Note : Don't store the **DOGTROPHY** for a long time with an empty battery if you want to keep good performance of the **DOGTROPHY**. Charge the Dogtrophy at least once a month

HOW TO START

- ▶ Press the ON/OFF button ② to start the **DOGTROPHY**
- ▶ The ON/OFF LED ② will start blinking very quickly
- ▶ Press one stimulation button of the remote control until the ON/OFF LED ② stop blinking quickly
- ▶ The ON/OFF LED ② blink once every 5 seconds
- ▶ Press the stimulation button once more to start again the **DOGTROPHY**'s mechanism
- ▶ This operation must be done each time the **DOGTROPHY** is started

ATTENTION

- ▶ DO NOT USE OTHER BALLS THAN THE BRAND WE DELIVER
- ▶ DO NOT USE MORE THAN 3 BALLS BY ADDING ANOTHER TUBE ON TOP OF YOUR **DOGTROPHY**
- ▶ NEVER OPERATE MANUALLY THE PINS AT THE INSIDE
- ▶ NEVER TRY TO BLOCK OR HOLD THE PINS (MANUALLY) AT THE INSIDE OF THE TUBE
- ▶ **DOGTROPHY** IS NOT WATERPROOF
- ▶ DO NOT SUBMERGE UNDER WATER,
- ▶ PROTECT THE **DOGTROPHY** FROM RAIN
- ▶ DO NOT PUT ANY OIL OR OTHER LUBRICANT ON THE PINS INSIDE OF THE PLASTIC TUBE
- ▶ DO NOT USE **DOGTROPHY** UNDER OR ABOVE EXTREM T° (-20°C OR +40°C)

If you are no longer using this material or if it cannot be repaired, do not throw it away in the usual household rubbish.


